

POLICE OPERATIONS

The Danville Police Department Operations Division is the largest section of the police department. It is also the one that most citizens come in contact through our various law enforcement activities. In 2009 this Division was responsible for most all of the 88,972 calls for service responded to by the Danville Police Department. The units of the division include the Patrol Unit, Community Police Unit, and Investigations Unit. This division is the face of the police department to most of the citizens. Most of the 9,713 traffic summonses and 3,811 criminal warrants issued were served by Operations officers. These officers also took the majority of the 8,692 reports written in 2009. As these numbers indicate police officers are very busy people indeed. This does not mean that the Danville Police Department has gone along with the ideal of "fast food law enforcement". The police officers employed here are interested in doing the best job possible for the citizens of Danville, and committed to making the city a safe place to live.

One such instance is demonstrated in the event detailed below;

At Approximately 9:06AM dispatch received a call that there was a propane gas leak from a 500-gallon tank at <u>329 Westover Drive</u>

Riverside Equipment. City of Danville Fire Department was dispatched to the scene. The gas tank was located outside and behind the business. At 09:17 The City of Danville Fire Department requested the assistance from the Danville Police Department to evacuate a circumference area from the gas tank of ½ of a

mile. A secondary Incident command was established by the Danville Police Department for evacuation efforts and coordination. Residential homes on Riverview Dr. as well as Westover Dr. within a ¼ mile radius had to be evacuated; the Pleasant View Apartment Complex had to be evacuated. The following businesses had to be evacuated The Westover Dr. United Postal Service Building - Danville Collision – El Vallarta Mexican Restaurant – International House of Pancakes. The Command Post was located at the west end of Sam's Club Parking Lot, all evacuated addressed were documented and logged in at the command post. An evacuation control and staging area was established in the parking lot of K-Mart.

Individuals that had to be relocated would receive updates and information on when it would be safe to return home. The evacuation area of ¼ mile and the effort it would take to relocate individuals within the affected area was a major incident that was conducted and completed within the time frame of 9:17AM Danville Police on the scene & 10:55AM when the incident was contained and it was cleared to allow homeowners and business persons to return to their respective homes and businesses. This was a truly monumental task to have completed in less than two hours, events such as this are not typical in Danville however it is a typical example of the outstanding work carried out every day by the Danville Police Department.

POLICE SERVICES

The Danville Police Department Services Division continued to support the public service goals of the department by improving the efficiency of how police officers conduct law enforcement activities.

In 2009, twenty-two marked police units were equipped with Sierra Airlink cellular modems. These modems are a key piece of equipment vital to many different applications. The modems allow a constant connection to the department's computer databases. This has increased the field capabilities of the police officer exponentially. Officers now have the ability to fully utilize programs in their computers to their full potential. Programs like Linx, a database used to store multijurisdictional criminal justice information, and the Virginia Criminal Information Network are instantly available to officers in their vehicles no matter where they are. These databases allow officers to run vehicle, driver, and suspect information, including mugshots, at anytime.

The officers also remain in continuous contact with each other and with dispatch through the Mobile Data Browser program installed in the police vehicle computer. Officers can review all of the outstanding calls in the system. They can receive calls from Dispatch, acknowledge them by marking themselves in-route, and clear up from the call without touching the police radio. This has eliminated a large amount of radio traffic and the information sent is more secure due to the fact scanners cannot decode it. Information stored in the Computer Aided Dispatch can now be directly updated by police officers, ensuring more accuracy in that database. Mobile Data Browser allows officers to send text style messages car-to-car and back to dispatch or the patrol supervisor. Patrol supervisors can update the roll call page with bulletin information and alert information.

Another data sharing program called P2P (Police 2 Police) was brought on line. This program allows all law enforcement agencies using SunGard HTE as a vendor for their records management system to share the information contained therein. This system increases the number of agencies Danville officers can mine information from. This information is live and admissible in court, in contrast to that found in the Linx system which is 24 hours behind and not considered original information.

There are several other programs currently being evaluated for use. An automatic vehicle locater (AVL) program is currently in the final stages of implementation. Using AVL will allow officers, dispatch, and administration to be able to locate all active police vehicles on a map in real time. This will be a useful tool to increase officer safety. Dispatch will be able to look on the map and send the nearest available police car to a call, decreasing police response time. AVL can be configured to record police patrol patterns for later comparison to crime patterns.

Yet another solution being explored is the use of an e-ticket system. This system will allow officers to swipe a driver's license through a reader, enter offense information, and allow the driver to sign a screen. A ticket would print out like a retail receipt and be presented to the offender. The information would then be transmitted back to the police and court computer servers automatically. This would also increase officer safety because the officer would be able to limit the time he or she is distracted doing paperwork.

TOP NEWS STORIES FOR 2009

HOMICIDE

On 12-25-09 at 8:35 PM, Danville Police responded to a reported shooting at 402 North Ridge Street. It was reported to police that a man had been shot at this residence. Officers arrived at approximately 8:36 PM to find the victim of the shooting laying on the floor suffering from a gunshot wound to the neck. The 75-year-old male victim, Robert Lee Terry of 402 North Ridge Street in Danville, died at the scene as a result of his injury. The shooting suspect, Jeffrey Kent Graves, 47 years old, of Danville was arrested at the scene. Graves was charged with first degree murder, and was held in the Danville City Jail without bond.

SHOOTING

On 12/15/09 at 10:59 pm, the Danville Police Department received a call in reference to someone being shot in the 500 block of Bradley Rd. Upon arriving at the scene, officers found the victim with multiple gunshot wounds. The female victim, who lives in Danville, reported that her husband had shot her. The victim was transported to D.R.M.C. with life threatening injuries. Suspect vehicle information was obtained and given out to surrounding jurisdictions. At 1:18 AM, 12/16/09, Caswell County Sheriff's Office called and reported that they had apprehended the suspect on Hwy 86 approximately four miles south of Yanceyville, NC. Warrants were obtained for Homer Wilkerson of Danville for Aggravated Malicious Wounding, and use of a firearm in the commission of a felony. Wilkerson was held in Caswell County without bond awaiting extradition back to Virginia.

TRAFFIC FATALITY

On 12-15-09 at approximately 6:20 am, the Danville Police Department and rescue personnel responded to 625 Westover Drive in reference to a car crash. Ann Gray Towler, age 61, of Danville was attempting to cross Westover Drive in an electric wheelchair. Towler had crossed the East bound lane and was in the West bound lane, when the driver of a 1994 Honda Accord attempted to swerve around her. Towler was struck by the front passenger side of the vehicle. Towler was transported to the Danville Regional Medical Center by the Danville Life Saving Crew but was pronounced dead at 7:16 am

HOMICIDE

On 12-11-09 at approximately 1:32 am, Arnold McKinley Epps was found unresponsive at 414 Van Buren St. suffering from several major wounds to the head. The skull fractures he suffered sent him into a coma from which he never recovered. He was

transferred to Capitol Hill Hospital in Washington DC. Mr. Epps died on 4-23-10 while in their care.

SHOOTING

On 12-2-09 at approximately 2:00 PM, a male subject called the Danville Police Department and indicated he had a firearm and might harm himself. While an officer kept him on the line trying to keep him talking, other officers were dispatched to the address on Lanier Avenue. Shortly thereafter, an apparent gunshot was heard by the officer talking to the subject on the telephone. The responding officers forced entry into the residence and found a 54-year-old male suffering from a gunshot wound to the head. Rescue units transported the male to the Danville Regional Medical Center where he was listed in critical condition at the time of the incident.

MURDER INDICTMENT

On 11-17-09, Indictments for murder and use of a firearm in the commission of a felony were served on 29-year-old Danville Resident Curtis Wayne King. King was indicted for his part in the murder of Garland Thomas Glass Jr. The homicide took place on 9-11-03 at the Express Line convenience store, 1619 Richmond Avenue. King was serving out a sentence for other charges when the indictments were served on him.

MALICIOUS WOUNDING ARREST

On 11-22-09 a Danville resident reported that she was stabbed in the 200 block of Epps Street at approximately 10:15 P.M., by a male acquaintance. She suffered from knife wounds to the throat and chest. The victim was transported to the Danville Regional Medical Center for treatment of non-life threatening injuries. After the incident, Danville Police officers located the suspect, 36-year-old Dexter Elliott Logan, on Grace Street. He was arrested without incident and charged with malicious wounding in violation of Virginia Code 18.2-51.

JUVENILE WITH AN AIR RIFLE ASSAULT POLICE OFFICERS

On 11-18-09 at approximately 9:12 AM, Danville Police responded to a disturbance call in the 500 block of Chatham Avenue. When the officers arrived, a 15-year-old juvenile male barricaded himself in an upstairs room and started shooting at them with an air rifle. One officer was struck in the leg as he was getting out of a police cruiser. Officers learned the juvenile had also shot his mother with the air rifle before they arrived. Officers employed a police shield and were able to make entry into the area were the juvenile was barricaded. During the entire time officers were making entry, the juvenile was pumping the air rifle to give it more power and shooting at them. The officers were able to pin the juvenile down with the shield and take him into custody without injuring him or sustaining more injuries themselves. A baseball bat was also found in

near proximity to the juvenile. The officer who was struck in the leg by a pellet suffered only a minor injury and returned to duty. The juvenile was charged with felony assault for shooting at and striking the first officer and five counts of assault on a police officer for shooting at other officers on the scene. He was taken to W.W. Moore Detention Facility. Officers showed great restraint and professionalism while working together as a team in such a dangerous environment to take the juvenile into custody without injury.

ROBBERY ARREST

On 11-16-09, at approximately 2:02PM, Danville Police responded to a reported robbery at the Nature's Essentials store at 107 Mall Drive. The clerk reported that a male subject came in to the store, produced a gun, and demanded money from the register. She said after the subject took an undisclosed amount of cash he then ran out of the store. The subject was last seen running towards a wooded area behind the AT&T Wireless retail store. A search was initiated by police units. A Danville man, Shauntra Poole age 20 was eventually located in the Pleasant View Apartment Complex. Poole was taken in to custody. Poole was charged with armed robbery, and use of a firearm in commission of a felony for his role in the robbery. There were no reported injuries in this incident.

HOMICIDE

On 11-12-09 at 2:30AM, Danville Police responded to the 1300 block of Washington Street in reference to a shots fired call. Officers discovered a male subject in the roadway suffering from an apparent gunshot wound. Rescue units responded to the scene and transported the subject to the Danville Regional Medical Center where he died approximately one hour later. The subject was later identified as Danville resident James Willie Adams age 35.

GUN REPORTED ON DANVILLE COMMUNITY COLLEGE CAMPUS

On 11-11-09 at 8:47 AM, Danville Police responded to the Danville Community College campus in regards to three subjects running across the campus towards the walking bridge. One subject was reported to be carrying a gun. The campus was locked down by the school administration. Police units started a search of the campus. During the search, student's vehicles were found to have been entered and a firearm was determined to be missing. As police units were investigating on campus, a report of shots fired was received from the Cardinal Village area. Police units moved quickly to that area and discovered someone had shot into a vehicle. Officers located three juveniles hiding in an apartment. Several items were recovered during a search of the apartment including the firearm that was missing from one of the vehicles. There were no reported injuries from this incident.

HOMICIDE

On 10-23-09 at 11:46 pm, Danville Police Officers responded to an assault call at 515 Madison Street. Upon the officers arrival they found a 14-year-old victim lying on the street suffering from a gunshot wound to the chest. During the course of the investigation Danville Police discovered two other shooting victims from the same incident. One of the victims was located at the Stonewall Recreation Center on Bradley Road. The other victim showed up at the Danville Regional Medical Center where he was treated for non-life threatening injuries. The victim from the Stonewall Recreation Center was also treated at the Danville Regional Medical Center for non-life threatening injuries. The 14-year-old later died while he was being treated. On 10-24-09 Quayshaun Malik Woods age 18 was charged with use of a firearm in commission of a felony in connection with the shooting incident related to the homicide.

GEORGE WASHINGTON HIGH SCHOOL LOCK DOWN

On 10-23-09 at 8:40 AM, Danville Police units responded to George Washington High School in reference to a student seen in possession of a gun by another student. In response to this sighting the administration of the school locked the school down. Officers were able to locate a B.B. pistol in a student's backpack. The lockdown continued while Police Officers verified that the campus was secure. There were no injuries incurred during this incident. Later that day during the course of the police investigation at George Washington High School two male juveniles one 15yrs old and another 16yrs old were charged with possession of a concealed weapon, and having a weapon on school grounds.

HOMICIDE

On August 25, 2009 at approximately 2:41 AM, the Danville Police Department received a call in reference to shots fired in the 1200 block of Wayles Street. Upon arriving at the scene, officers found a male and female victim suffering from what appeared to be gunshot wounds. Both victims were transported the Danville Regional Medical Center. The female was pronounced dead on arrival. The male victim suffered from a non-life threatening injury to the hand and was later released from the hospital. The female was identified as Ashley Dawn Wilson Echols age 26 of Danville. On 10-2-09 a grand jury handed down indictments in connection with this case. Robert Louis Winslow age 32 of Danville was indicted for: first degree murder, malicious wounding and two counts of use of a firearm during the commission of a felony. That afternoon Danville Police arrested Robert Winslow on Garland Street without incident on all charges. He was taken to the Danville City Jail where he was held without bond.

CAPITAL MURDER

On June 11, 2008 at approximately 8:48 PM, Danville Police were called to the 100 block of Cherokee Court for a reported shooting. Responding officers found a green 1997 Infiniti in the parking lot with the motor running. Officers found Darry Julius Wimbush age 25 of Danville unresponsive in the driver's seat of the vehicle. Further investigation revealed that Wimbush had suffered an apparent gunshot wound. He was pronounced dead at the scene. On 10-1-09, a grand jury convened and handed down indictments in connection with the case. Danville Police arrested Cordero Termont Edmonds age 21 of Pittsylvania County for indictments of capital murder of Darry Wimbush, robbery of Darry Wimbush, and use of a firearm during the commission of a felony. Edmonds was arrested in the Pittsylvania County Jail where he was incarcerated on unrelated charges. He was held without bond in Pittsylvania County Jail.

HOMICIDE

On September 18, 2009 at approximately 11:27 PM, Danville Police received a call to respond to the apartment building at 427 Wooding Avenue for a burglary in progress. Upon arrival, responding officers found a man suffering from an apparent gunshot wound lying in a grassy area near the building. Rescue personnel transported him from the scene to the Danville Regional Medical Center. A male resident of the apartment building reported that he was asleep in his apartment with his girlfriend and six month old child when he was awakened by the sound of breaking glass. He picked up his firearm, went into the livingroom area and saw an intruder. Both the resident and the intruder, Alex Richard Totherow reportedly ran from the apartment, at which time the resident fired a shot at Totherow. Totherow was pronounced dead at 12:15AM. On 9-30-09, a grand jury convened and handed down indictments for Stuart Lee White Jr. age 28 of Danville (resident of the apartment building) for second degree murder and use of a firearm during the commission of a felony in connection with the incident. White turned himself in this morning, was taken to the Danville City Jail, was released on a \$25,000.00 bond. White was later acquitted by a jury of all charges

HOME INVASION

On 09-14-09 at approximately 10:30pm, Officers responded to the 200 block of Baugh St. in reference to a home invasion. The victim reports that three black males wearing black clothing and masks, entered the home by prying open the rear door. Once inside, one of the suspects produced a handgun and demanded money. The victim and her eight year old child were bound with belts. The suspects ransacked the house and stole a H&K .45 caliber semi-automatic pistol. After the suspects fled the scene, the victim

was able to free herself and notify the police. No injuries were reported and no shots were fired.

SHOOTING

On 9-6-09 at approximately 3:00 A.M. Danville Police responded to the 200 block of West James Street in regards to a shots fired call. Responding officers discovered a house had been shot into several times. The house was occupied by five Danville residents. A juvenile female was transported to the Danville Regional Medical Center for a non-life threatening injury to her upper right arm; no one else suffered any injuries.

HOMICIDE

At approximately 2:40 A. M. on July 11th, Danville Police responded to the 200 block of Ross St on an initial report of a shots fired call. Officers found a 30 year-old female and a 19 year-old male, both Danville residents suffering from gunshot wounds. Fire and EMS also responded. The victims were transported to the Danville Regional Medical Center for their injuries. The 30 year-old female, Latoya Hubbard, died as a result of her injuries. The 19 year-old male was treated for his injuries and later released. On 9-2-09 1:30PM, Danville Police arrested Tremon Antonio Wimbush age 19 of Danville for the July 11, 2009 shooting death of 30 year old Latoya Hubbard. He was indicted by a grand jury for first degree murder and use of a firearm in the commission of a felony (VA S.C. 18.2-53.1) in connection with the incident. Wimbush was already incarcerated in the Danville City Jail for aggravated Malicious Wounding, use of a Firearm in the Commission of a Felony, and Possession of a Firearm by a Convicted Felon.

SHOOTING

On 8-31-09 at approximately 2:37 PM, Danville Police responded to the Libby Hill Restaurant on Riverside Drive in reference to someone being shot. Responding officers learned that a handgun accidentally discharged in the dining room. The single bullet struck the tile floor and broke apart. Three patrons from the restaurant were injured by fragments. All three of the people who were injured were taken to the Danville Regional Medical Center where they were treated for their non life threatening wounds. The person in possession of the handgun at the time of the accidental discharge was retired Danville Police Lieutenant, John William Martin Jr. age 73 of Blairs. Mr. Martin was eating lunch with a group of acquaintances when the firearm, which was tucked in his waistband, discharged after he stood up. Mr. Martin sustained minor injuries to his leg. Mr. Martin retired from the Danville Police Department over twenty years ago after thirty-two years of service. Mr. Martin passed away prior to the conclusion of the investigation due to natural causes.

TECHNOLOGY HELPS NAB THIEF

The Danville Police Department recently applied for a \$419,000 grant from Homeland Security to connect the records systems of twenty law enforcement agencies in Southside Virginia. The new system, called LINX for Law Enforcement Information Exchange, allows officers from each of the participating agencies to easily search the records of all the agencies via the internet. Several Danville Officers, including Sgt. Paul Deel, trained on how to use the LINX search engine program on August 18th. The next day an elderly woman reported that a man had taken her purse from her shopping cart in the parking lot of Sam's. Store video of the suspect showed a white male approximately 20 to 30 years old with black hair operating a Ford Explorer. Sgt. Deel decided to see what LINX could produce and entered those four parameters into the LINX search program. Within seconds he received 75 possible matches, two of which were from Danville. When Sgt. Deel looked at the mug shot photo of one of the Danville matches, it closely resembled the man in the store video. Further investigation confirmed the identity of the suspect as Daniel Ray Utterback and led to his arrest and recovery of the purse. Utterback also was charged with a similar purse snatching from another elderly woman in the Wal Mart parking lot on August 17th.

The search engine capability of the LINX system greatly enhances the ability of police officers to share information and solve crimes. The LINX system connects with other similar systems around the state and nation, allowing officers to search far beyond Southside Virginia if necessary. The LINX system will be available to officers in the field through the laptop computers mounted in the patrol vehicle.

HOMICIDE

On 08-14-09 at approximately 11:15PM, the Danville Police Department received a call in reference to shots fired in the 200 block of First Street. Upon arriving at the scene, officers found two gunshot victims in the street. Both were transported to the Danville Regional Medical Center. A short time later, Jermay Antonio Smith of Danville died from his wounds. The other victim was treated for his injuries and later released. As a result of the investigation, Danville Police secured a first degree murder warrant for Lantron Nakia Womack age 32 of Sutherlin in connection with the shooting death of Jermay Smith. Womack was reportedly operating a white 4 door Buick. On 8-28-09 at approximately 11:30AM, Lantron Womack accompanied by his attorney turned himself in to the Lynchburg Police Department. He was taken to the Lynchburg City Jail and later transported back to Danville for court proceedings.

HOMICIDE

On 8-25-09 at approximately 2:41 AM, the Danville Police Department received a call in reference to shots fired in the 1200 block of Wayles Street. Upon arriving at the scene,

officers found a male and female victim suffering from what appeared to be gun shot wounds. Both victims were transported the Danville Regional Medical Center where the female was pronounced dead on arrival. The male victim suffered from a non-life threatening injury to the hand. The female was later identified Ashley Dawn Wilson Echols age 26 of Danville.

POLICE OFFICERS PUT OUT FIRE AT APARTMENT BUILDING

On 8-21-09 at approximately 12:10AM, two Danville Police Officers working extra duty at the Purdum Woods Apartment Complex were notified of a fire inside of an apartment in the "K" building. Officers Torres and Jackson quickly responded, and put out the fire with a fire extinguisher. The Danville Fire Department responded and secured the area. The building was evacuated due to the smoke from the fire. No injuries were reported. The investigation revealed that the cause of the fire was unattended cooking.

SHOOTING

On 8-17-09 at approximately 5:45PM, Danville Police responded to an apartment in the 800 block of Grove Street with reference to a man who had been shot. The resident reported that he was inside his apartment when he was shot in the face. The shot was fired from outside the building by an unknown suspect. Rescue personnel responed and transported the man to the hospital where he was treated for his non life threatening injuries.

ROBBER APPREHENDED BY STOREOWNER

On 8/11/09 at 8:14 PM Danville Police responded to the Joy Food Mart 2180 West Main Street in reference to a possible robbery in progress. The call was received from a female outside the store that observed the incident. When officers arrived, they found the owner of the store and the suspect wrestling outside on the sidewalk. Officers apprehended Floyd R. Haizlip W/M age 27 of Danville. Haizlip has been charged with armed robbery, use of a firearm in commission of felony, wearing a mask in the commission of a felony and assault and battery on the store clerk. Haizlip was held in the Danville City Jail under no bond.

NEWS CONFERENCE

Chief Philip A. Broadfoot Danville Police Department July 22, 2009

During the fall of 2008 and the first several months of 2009, larcenies and burglaries in the City of Danville increased significantly. The increases were concentrated in the Druid Hills, Almagro and Beverstone neighborhoods, alongside Kemper Road, Piney Forest, Arnett Boulevard, Westover Drive and Riverside Drive, and in the parking lots surrounding the walking trail. The initial investigations revealed that these crimes were likely being committed by several different suspects or groups of suspects.

In March of 2009, a departmental task force was formed to focus on solving these crimes. The task force consisted of Sergeant H. S. Richardson, Detective D. C. Ferguson, and Officers S. M. Crews, K. L. Shackett, and J. L. Perkins. Their instructions were simple - find out who was committing these crimes and arrest them. The purpose of the news conference today is to recognize their outstanding work.

After the task force was established in March, a pattern of breaking into north Danville businesses in the Piney Forest Road, Arnett Boulevard, and Riverside Drive areas became apparent from the end of April through the beginning of June. Corell DaMain Jeffries was developed as the suspect in these burglaries and was charged with 11 burglaries or attempted burglaries. The businesses victimized and the charges made against Jefferies are as follows:

- Burglary and 3rd offense larceny at 339 Piney Forest Road, ERA Holley and Lewis Realty, which occurred on 04-22-09
- Attempted burglary at 538 Piney Forest Road, Cochran Insurance, which occurred on 04-24-09
- Attempted burglary at 1322 Piney Forest Road, Burnett Insurance, which occurred on 05-06-09
- Burglary and 3rd offense larceny at 530 Arnett Boulevard, Monumental Life, on 05-06-09
- Burglary and grand larceny at 2020 Riverside Drive, Suite A, Nationwide Insurance, on 05-11-09
- Burglary at 2020 Riverside Drive, Suite B, Team Nurse, on 05-11-09
- Burglary and 3rd offense larceny at 171 Piney Forest Road, Farmers Insurance, on 05-14-09
- Attempted burglary at 163 Piney Forest Road, Custom Alteration, on 05-14-09

- Burglary at 107 Northmont Boulevard, R J Baldwin Insurance, on 05-28-09
- Attempted burglary at 2012 North Main Street, Security Insurance Company, on 05-29-09
- Attempted burglary at 2012 Riverside Drive, USA Check Cash, on 06-12-09
- Possession of burglary tools from a police encounter on 06-12-09

The task force also charged 24 other individuals with crimes associated with 27 other burglaries or larcenies. The individuals charged and the victims are as follows:

- On 03-31-2009, Jerry Lynwood Barbour was charged with burglary of the Nazarene Baptist Church on Franklin Street from a July 2008 incident
- On 04-01-2009, Justin Lomar Craig was charged with burglary of and grand larceny from Northside Video at 1667 Piney Forest Road
- On 04-04-2009, Harold Dennis Hall was charged with burglary of and grand larceny from a Carlson Avenue residence
- On 04-16-2009, Damien Laquan Skipper, Latasha Nasha Bland, Helen Shanqual Younger, and a 17-year-old juvenile were arrested for the burglary of a Parker Road residence
- On 04-22-2009, a juvenile suspect was charged with burglary of and grand larceny from a residence on Northmont Avenue and stealing the vehicle belonging to the residents
- On 04-27-2009, Kent Saddler was arrested for the burglary of a Halifax Road residence
- On 04-29-2009, Robert Marion Register and Robert Lee Wallace Jr. were charged with the burglary of and grand larceny from the North Main Citgo, 1210 North Main Street and the Fasmart store at 602 Arnett Boulevard in April of 2009
- On 05-14-2009, Latroy Asaiah Edmonds was charged with burglary of and petit larceny from a south side residence
- On 05-16-2009, Torry Jermale Venable was arrested for burglary, grand larceny, and three credit card related charges from a burglary of a Melville Avenue residence that occurred on March 8, 2009
- On 05-18-2009, Ernest Mack Jones III was charged with burglary and aggravated sexual battery from an incident at Purdum Woods Apartments
- On 05-20-2009, Anthony Ramain Malone was arrested for trespassing and damaging the upstairs area of the commercial building located at 312 Main Street. The follow-up investigation led to Anthony Malone being charged with burglary of the Mecca Moon clothing store located on Main Street from an incident that occurred on 05-14-2009

- On 05-31-2009, Nicholas Scott Hooker was arrested for burglary of and petit larceny from the Quick and Plenty store on Memorial Drive. After follow-up investigation, Hooker was also charged with two counts of burglary and grand larceny from The Professional Pharmacy on Watson Street from 05-27-2009 and 05-29-2009 incidents. Hooker was also charged with burglary of and petit larceny from the Midtown Market on Chambers Street on 05-04-2009
- On 06-09-2009, Keith Obryant Fitzgerald was charged for larceny of items from a vehicle at Stallings Collision on Riverside Drive
- On 06-18-2009, Antonio Lawarren King was charged for burglary, grand larceny, and selling stolen property from a May 2009 burglary of the Pentecostal Holiness Church located at 501 Bradley Road
- On 06-18-2009, Natasha Lynette Younger was charged for burglary, grand larceny, and filing a false police report from the 04-01-09 burglary at Northside Video
- On 06-29-2009, Matthew Ryan Sutterlin, Seth Blackwell and a 17-year-old juvenile were charged for five separate burglaries of local churches. Woodlawn Baptist Church on Westover Drive was the victimized once. Fairview United Methodist Church on Westover Drive and Brush Arbor Baptist Church on Blair Loop Road were victimized twice.

The task force determined that two main groups were involved in a majority of the other reported burglaries. The first group consisted of James Shawn Sarver, Jennifer Ann Rowland, and Gabriel Paul Cox. The investigation revealed that James Sarver and Jennifer Rowland were the ringleaders and were responsible for numerous larceny offenses throughout Danville between December 2008 and their arrest on March 25, 2009. The majority of the larcenies took place in the parking lots that citizens used to access the walking trails in Dan Daniel and Ballou Parks and beside Riverside Drive and the Community Market. Sarver and Rowland worked as a pair to steal from parked vehicles. They then used the credit cards and identifications found in the stolen purses to make fraudulent purchases at area businesses. The pair was also found to be responsible for other burglaries dating back to 2006. James Sarver was charged with a total of 70 burglary, larceny, or credit card related offenses. Jennifer Rowland was charged with a total of 56 similar offenses and Cox was charged with one larceny offense. The investigation also led to additional charges against the pair in Pittsylvania, Halifax, and Charlotte Counties. Search warrants obtained as a result of this investigation led to the arrest of three more individuals. Richard Howard Whitstyne and Corey Washington were arrested and charged with possession of stolen property received from Sarver and Rowland. Whitstyne was also charged with possession of cocaine with intent to distribute. The third individual arrested was Ghulam Hassan, the proprietor of PAK's Supermarket on Westover Drive. A stolen air compressor, saw, and two nail guns were recovered from the supermarket and Hassan was charged with

twenty counts of possession of untaxed cigarettes after an undercover operation there on April 9, 2009.

The second group was responsible for numerous residential burglaries along Westover Drive, Kemper Road and in the Druid Hills, Almagro, and Beverstone neighborhoods of Danville. Interviews of several suspects led to the discovery of a local gang, called "The Runners", who operated as a "Bloods" criminal street gang. The Runners had been in existence since the summer of 2008 and were working in conjunction with "West Mo", another Bloods criminal street gang. The Runners operated mainly from the Druid Hills neighborhood and WestMo operated from the Westmoreland neighborhood. Nine juvenile members of The Runners have been arrested to date. The nine juveniles associated with the gang have been charged with a total of 33 counts of burglary, 33 counts of grand larceny, 1 count of possession of a firearm as a convicted felon, 14 counts of criminal street gang participation, and 1 count of recruiting a juvenile into a criminal street gang. The Runners and West Mo gangs also included adult members who either participated in the burglaries or were responsible for selling the stolen property. The gang started their burglaries in their own neighborhoods and then branched out to other parts of the City. The younger gang members would walk through a neighborhood and select homes where no one appeared to be home. They would knock on the door and if someone answered, they would politely ask for someone by name, ask for a drink of water, or ask for directions. If they discovered that no one was at home, they would forcibly enter and steal money, firearms, TV's and electronic items. The stolen items either were carried away, hidden nearby for later retrieval, or immediately loaded into a waiting vehicle. The gang members sold the property on the street or fenced it to several individuals who in turn would take it to local pawn shops or second hand stores. Some of the property stolen by these two criminal street gangs was recovered from the pawn shops and second hand stores and returned to the owners.

Eight adult members associated with the two gangs have been charged with a total of 44 offenses that included burglary, larceny, gang participation, firearms violations and malicious wounding. The eight adults are Tremon Wimbush, DeAnthony McMoore, Karlec Larico Metts, Reginald Robertson, Jerrod Allen Jamal Wimbush, James Lloyd Williams II, Tyler Jamar Turner and Lamberth Powell. The investigation into the Bloods gang activities and the crimes they are believed to be responsible for is ongoing. More charges in relation to their activities are expected. Many of the suspects charged in all of these crimes have already been prosecuted in court and convicted.

For background information, in 2003 the Danville Police Department announced that gang activity had been detected within the city and embarked on a program of educating parents, children, and school personnel about gangs. I am particularly impressed with the support that our local school system has provided since that announcement. School administrators have taken a no tolerance stance against gang

signs, clothing, activity, and graffiti. I believe those actions contributed more than anything else to the suppression of gang activity in Danville during the last six years. During the past six years we have monitored a number of gangs as they have started up, grown, disbanded or fallen apart. All of the gangs have a neighborhood or geographic basis. The gang begins as a collection of friends and acquaintances in a neighborhood and then establishes a name, signs, clothing, tattoos or entry criteria. While members of the gangs have constantly engaged in various individual criminal acts, we have been unable to prove until now that the gangs themselves engaged in concerted and overt criminal activity. It is this collective criminal activity that makes participation in a gang illegal and allows law enforcement to take specific action against a gang.

Beginning in 2008 we noticed the first signs of significant criminal activity by neighborhood gangs. These gangs were heavily involved in the distribution of drugs and the use of violence and firearms to accomplish these crimes. We were able to arrest some members for various individual offenses but were unable to obtain the necessary evidence to make criminal street gang charges. It was not until the creation of this task force that we were able to gather the evidence and identify thirty members of The Runners gang and disable it significantly by making numerous arrests. The leader of The Runners, who was also a member of WestMo, was identified by numerous gang members as 18 year old Tremon Wimbush. Because many people were frightened of Wimbush and afraid to testify, we were initially unable to develop a criminal case against him. Nevertheless, we continued to keep pressure on the gang. On July 2nd Corporal Todd Hawkins noticed Wimbush in a group of men at Cedar Terrace Apartments and arrested him for drunk in public. When Corporal Hawkins searched him, he discovered a stolen .45 caliber pistol in his waistband and \$1,300 in counterfeit currency. A crowd of bystanders interfered and tried to prevent the arrest, but Hawkins called for backup and was able to keep the crowd away from his prisoner. Wimbush was released on bond for these charges and became a person of interest in a number of subsequent shooting incidents throughout the city. It was not until the tragic murder of Latoya Hubbard, an innocent bystander, on Ross Street on July 11th that we were able, with the help of the Commonwealth's Attorney's office, to bring a major criminal charge of malicious wounding against Wimbush and an accomplice, DeAnthony McMoore. I am hopeful that Wimbush's arrest will bring an end to his spree of violent activities and the fear that he has inflicted on the citizens of Danville and particularly the residents of Ross Street.

The members of this task force have had phenomenal success in solving these crimes. All together they made 283 adult charges and 92 juvenile charges, for a grand total of 375 criminal charges in the short space of just over four months. They worked hard, they put in many hours, they worked around the clock, and they succeeded beyond all

expectations. Gentlemen, on behalf of the Danville Police Department and the citizens of Danville, thank you. It is my privilege to present to each of you a Departmental Commendation recognizing your exceptional work on the task force. Congratulations.

HOMICIDE

At approximately 2:40 A. M. on 7-11-09, Danville Police responded to the 200 block of Ross St on an initial report of a shots fired call. Officers found a 30 year-old female and a 19 year-old male, both Danville residents suffering from gunshot wounds. Fire and EMS also responded. The victims were transported to the Danville Regional Medical Center for their injuries. The 30 year-old female, Latoya Hubbard, died as a result of her injuries. The 19 year-old male was still being treated at the time of this release. Hubbard's body will be taken to the Medical Examiner's Office in Roanoke for an autopsy. On 7-15-09 Danville Police charged Tremon Antonio Wimbush age 19 of Danville with shooting the 19 year old male in this case. On 09-09-09 Danville Police have arrested DeAnthony Lamar McMoore age 20 of Danville in connection with the shooting. McMoore was charged with; Attempted Murder Attempted malicious wounding Use of a Firearm in the Commission of a Felony, Possession of a Firearm as a Convicted Felon. He was held in the Danville City Jail under no bond.

HOMICIDE ARREST IN 2008 CASE

On 06-26-09 18-year-old Danville resident Travis Coleman Lewis was arrested and charged with first degree murder for his actions in the below described homicide of his mother Brenda Marie Lewis.

On 8-15-08 at 4:45 A.M., Danville police responded to the 700 block of Holland Road in reference to a reported stabbing. Police discovered Brenda Marie Lewis age 40 dead in the front yard of her residence. Lewis suffered from multiple apparent stab wounds. Lewis' 17-year-old son was at the scene and also suffered from some non-life-threatening stab wounds. Lewis' body will be sent to the Roanoke Medical Examiner's Office for autopsy. The 17-year-old son was transported to the Danville Regional Medical Center for treatment.

MAN CHARGED WITH BURGLARIES

On 05-31-09, at 2:07 AM Danville Police responded to an alarm at the Quick-N-Plenty convenience store, 563 Memorial Drive. Officers found that the front glass had been broken out. The storeowner advised that a large amount of cigarettes were missing. The in-store video showed a white male wearing a grey hooded sweatshirt enters the store and take the items. The K-9 officer arrived and conducted a search. Officers found

Nicholas Scott Hooker age 18 of Danville hiding under some brush in the rear of a house in the 600 block of Ridge Street. Hooker was charged with breaking and entering and petit larceny. Further investigation revealed that Hooker was involved in other burglaries in the City of Danville. On 6-4-09 Hooker was charged with the burglaries of Midtown Market on Chambers Street on May 3rd, and two burglaries of Professional Pharmacy on Watson Street on May 27th and May 29th. In all, Hooker was charged with four counts of burglary and four counts of larceny.

HOME INVASION ARRESTS

On 5/31/09 at approximately 2:00 AM Danville Police received a call from the 500 block of Cedarbrook Drive that three white males had kicked open the front door and entered. Once inside the house, the males assaulted the victim with handheld weapons. The victim was transported to Danville Regional Medical Center and later transferred to Roanoke for head trauma. All three suspects were identified and charged. On 6-1-09, Danville Police arrested Ronnie Wayne Pruitt age 26 and Timothy Gordon Wilson age 27 both of Pelham with aggravated malicioius wounding and burglary. Later in the evening, the third suspect in this case turned himself in at the Danville Police Department. John Lindsey Pruitt, age 27,of Pelham, North Carolina was arrested on warrants for aggravated malicious wounding and burglary.

MOST WANTED CAPTURED

Santana Wimbush, a fugitive from Danville for over two years was captured on 6-1-09 in Rockingham County, North Carolina. He has been featured as one of Danville's Most Wanted since February of 2007 for his involvement in a shooting incident at Eli's Bar and Grill on South Ridge Street in Danville which left a Danville man paralyzed. He was captured as the result of a team effort which paired the U.S. Marshals and the Rockingham County Sheriff's Office. Wimbush is currently incarcerated in Wentworth pending extradtion proceedings. He faces charges of malicious wounding, use of a firearm during the commission of a felony, and discharging a firearm a firearm in a public place.

ROBBERY ARREST

On April 17, 2009 at approximately 4:02AM, Danville Police responded to the 400 block of Richmond Avenue. Ten citizens inside the residence reported that two males knocked on the door, then entered. The two men demanded money and jewelry from the people inside. Initial reports indicated that both men were armed. The investigation has revealed that only one of the suspects had a weapon while the other collected money from the people inside. One of the citizens assaulted one of the suspects who had a gun causing him to drop his firearm. The suspect quickly retrieved his firearm and fled the scene with his criminal counterpart. Some of the victims inside the

residence chased after the suspects, but were not able to catch them. One suspect was described as a light skinned black male with whiskers, 5'8" to 5'10" wearing a dark shirt and blue jeans. The other suspect was black male, heavy build, 5'8" to 5'10" wearing a gold hooded sweatshirt. The suspects left the scene with an undisclosed amount of money and assorted jewelry. No one was injured in the incident. On 4-27-09, Danville Police arrested Domanic Jonzell Jones age 28 of Danville on charges of: Robbery, Use of a Firearm in the Commission of a Felony, and Possession of a Firearm by a Felon.

SHOOTING

On 3-31-09 at approximately 8:50PM, Danville Police were dispatched to the intersection of Baugh Street and Oxford Street in reference to a report of a shooting victim. When police arrived they discovered a male victim suffering from a gunshot wound. While police were on the scene investigating the shooting, police were notified that a second male victim had arrived at the Danville Regional Medical Center suffering from a gunshot wound. While police were interviewing the second victim, a third male victim suffering from a gunshot wound arrived at the Danville Regional Medical Center. Two of the victims were treated for their injuries and released, one victim was transported to the University Of Virginia Medical Center. The status of the victim at UVA was critical. Police have determined that the shooting victims were all involved in the same incident. Danville Police have charged a 17 year old male with two counts of malicious wounding and one count of use of a firearm during the commission of a felony. His name and photograph were not released due to his age.

HOMICIDE

On 3-18-09 at 1:10AM, the Danville Police Department, the Danville Fire Department, and the Danville Life Saving Crew were called to the 400 block of Richardson Street with reference to a shooting. Responding officers found a man and a woman who were both suffering from apparent gunshot wounds. The man was pronounced dead at the scene, and the woman who was severely injured was transported to the hospital. The identity of the male victim was determined to be Troy Lee Martin age 41 of Danville. The female's identity was not revealed because she was still a live victim. There was a 10 year old juvenile in the house at the time of the incident. The juvenile was unharmed in the incident.

OPERATION SPRING CLEANING

"Operation Spring Cleaning" was organized as a drug interdiction operation. The operation targeted street level drug dealers and netted several charges and seizures. Operation Spring Cleaning was comprised of law enforcement officers from the Danville Police Department, Pittsylvania County Sheriff's Office, Virginia State Police, Alcoholic Beverage Control, Danville/Pittsylvania County/ Virginia State Police

Drug Task Force, and the Bureau of Alcohol Tobacco Firearms and Explosives. The operation began on Thursday and ended early Sunday morning. Resulting in 34 Criminal and 88 Traffic arrests. Additionally, four search warrants were served for narcotics and alcohol during the operation. As a result of the search warrants, marijuana weighing approximately 118 grams, several rocks of crack cocaine, \$2010.00 in cash and six handguns were seized. A large amount of alcohol which was being resold for a profit by the occupants was also seized from a house in the 900 block of Stokes Street. Approximately 93 bottles of beer and 18 bottles of assorted distilled spirits were seized.

BURGLARY ARREST

On January 17, 2009 during the nighttime hours, the PAK Supermarket on Westover Drive was burglarized. The cash register containing an undisclosed amount of money was taken from the business. Danville Police Investigators developed two suspects in the case. On 3-3-09, police charged Matthew Wilson Jordan age19 of Chatham with breaking and entering and grand larceny.

HOME INVASION SUSPECT ARRESTED

On October 9, 2008 at approximately 10:45 P.M., Danville Police responded to a report of a home invasion on Kemper Road. Two Danville residents reported at 11:25 PM three unknown subjects were knocking on the front door yelling "police" as they kicked in the door. Two suspects were wearing gray hoodies and one was wearing a white t-shirt, all three had on ski masks. The tallest suspect was armed with a handgun. One of the residents went to the front door armed with a handgun. The suspect fired at the house and the armed resident returned fire at the suspect. One bullet entered the house. Officers checked the area and there was no reported damage to any other house on the street. Nothing was taken and there were no injuries in this incident. On 2-20-09, police arrested Cody Detrick White age 27 of Danville in connection with the incident. White was charged with: Breaking and Entering use of a Firearm during the Commission of a Felony and Wearing a Mask in the Commission of a Felony.

ROBBERY


On 1-20-09 at approximately 7:17pm, officers were dispatched to the Fas Mart, 602 Arnett Boulevard, in reference to an armed robbery. The clerk reported that she was robbed by three males, one armed with a handgun. The suspects fled the scene on foot. A responding K-9 officer started a track and located 19 year old Damarcus Andrew Peatross of Danville hiding under a shed behind houses in the 100 block of Guilford Street. Peatross was apprehended and charged with armed robbery and use of a firearm in commission of a robbery. The other two suspects were described as short black males, wearing dark clothing and having their faces covered.

TRAFFIC FATALITY


On January 11, 2009, at approximately 9:55PM, Danville Police responded along with the Danville Fire Department and the Danville Life Saving Crew to the median area in the 2800 block of Riverside Drive in reference to a traffic accident. Responding officers found that a 2005 Chevrolet Corvette had left the roadway and struck a tree in the grassy median area. The initial investigation revealed that the Corvette had been driven by Charles Wayne Barnett Jr. age 38 of Pittsylvania County. The passenger in the vehicle, Thomas Gardner Ford age 38 of Pittsylvania County was killed as a result of injuries he sustained in the accident. Barnett was also transported to the Danville Regional Medical Center where he was treated for non life threatening injuries. On 3-4-09, a grand jury handed down indictments against Barnett for involuntary manslaughter and D.U.I. Barnett turned himself in to police and was taken to the Danville City Jail and released on \$25,000.00 bond.

HOMICIDE ARREST FOR 2008 CASE


On December 27th, 2008, at approximately 2:17AM the Danville Emergency Operations Center received a 911 call in reference to shots fired at the IHOP Restaurant on Westover Drive. Shortly after the initial call, another call was received that a male had been shot and was lying in the parking lot at IHOP. Police responded and found an unresponsive man lying in the parking lot with multiple gunshot wounds to his body. Tyrone Smith age 23 of Danville was pronounced dead at the scene. Another male, identified as Travoris Deaundre Howerton age 23 of Pittsylvania County was wounded in the incident and was treated at the hospital with a non-life threatening gunshot wound. On 1-06-09, a grand jury handed down indictments for 1st degree murder and use of a firearm in the commission of a felony against Howerton. Howerton was arrested by members of the Danville Police Department and the Pittsylvania County Sheriff's Office without incident. He was held in the Danville City Jail under no bond.














