The City of Danville is a participating jurisdiction under the U.S. Department of Housing and Urban

Development (HUD) Community Development Block Grant (CDBG) and HOME Investments Partnership (HOME) programs. A prerequisite for the City to receive CDBG and HOME funds is the development of a Consolidated Plan. Basic goals of the Plan are: (1) Decent Housing; (2) Suitable Living Environment: and (3) Expanded Economic Opportunities. All funded activities must address one or more national program objectives: benefit low- to moderate-income persons, aid in the prevention or elimination of slums or blight, or meet an urgent community need for which no other funds are available. The City has prepared a one-year Action Plan that specifies projects and activities to be funded during the coming year. The City anticipates a total budget of \$1,333,522.00 for fiscal year 2016-2017 (71/16-6/30/17), comprised of \$817,923.00 CDBG funds, \$215,599.00 HOME funds, and \$300,000.00 estimated
