



Danville Police Department 2016: Year in Review

2016 was challenging year for the Danville community and the Danville Police Department. The number of homicides during the 2016 calendar year has broken records and brought renewed focus on the issue. Violent crime, and the fear of violent crime, is a concern for everyone in the City of Danville.

Listed below are some basic facts that can inform the reader about crime in Danville.

- Overall, four of the five categories of felony violent crime (murder, robbery, abduction, aggravated assault) have been trending down during the last ten years in Danville. Only forcible sex has trended up, and that trend didn't start until 2010.
- The record number of homicides in 2016 after the record low of only three homicides in 2012 and 2014 may be the start of an upward trend or an isolated anomaly. That will be determined by the statistics during the next several years.
- Danville's crime rate is based on the number of offenses that are reported to police and for which a report is taken. We can confidently say that we take a report on all of our reported crimes, which results in over 5,000 crime reports per year.
- Out of the 38 cities in Virginia, Danville was second for 2015 in our crime rate.

### Danville Police Department 2016: Year in Review

- Total felony violent crime for 2015 was 294 out of the 5,020 crimes reported, which is a percentage of 5.8%. For comparison, Petersburg was 11.0%, Lynchburg was 9.0%, Radford was 8.5%, Charlottesville was 6.6%, Martinsville was 5.5%, Richmond was 3.6%, Roanoke was 3.5% and Salem was 2.2%.
- An estimated 200 of the 294 felony violent crimes are between people who know each other.
- If no felony violent crime had occurred, Danville would have still remained in second place in its overall crime rate.
- Non-violent crime, for which we take a report of every instance reported to us, is what drives Danville's crime rate.
- 1,407 simple assaults, 1,360 larcenies, 815 vandalisms, 684 drug/narcotic and 320 burglary offenses comprised 91.4% of the 5,020 crime reports in 2015 and are the five categories that drive our crime rate.
- Almost all of the 1,407 simple assaults were between people who knew each other and who reported or obtained a warrant for the assault because they have faith in the criminal justice system's ability to handle their dispute.

### Danville Police Department 2016: Year in Review

- Approximately 34% of the larcenies are shoplifting cases from several businesses.
- The 684 drug/narcotic cases are police initiated. Our crime rate rises when officers make drug arrests
- We have been successful in reducing our burglaries from the 500 to the 300 range during the last three years by using directed patrol based on patterns of occurrence.

#### Crime in the City of Danville for 2016

We classify crimes as overall, major and violent. Here are the preliminary assessments:

- For 2016, our overall crime rate dropped to the lowest in over a decade.
- For 2016, our aggregate major crimes (murder, forcible sex, robbery, aggravated assault, burglary, larceny, motor vehicle theft, and arson) dropped to the lowest since 2000 when we started following them (see chart below)
- For 2016, our violent crimes (murder, robbery, abduction, forcible sex and aggravated assault) were up about 24%, from 294 in 2015 to 366 in 2016. Out of the total of 72 additional violent crimes, 62 were an increase in aggravated assaults and 10 were an increase in murders. Robbery and abduction went down 13 and forcible sex was up 13. Aggravated assaults are up because we started reporting the crime properly over a year ago by listing each person in a home during a drive by shooting as a separate aggravated assault crime victim.

### Danville Police Department 2016: Year in Review

The following are the numbers of major crimes (murder, forcible sex, robbery, aggravated assault, burglary, larceny, motor vehicle theft, and arson) in Danville since 2000. Even factoring in a population decrease of 10.4% from 48,000 to 43,000 during the 17 years, the rate of decrease in these crimes is about 43%, which is outstanding.





#### **Homicide Totals**

Regardless of our felony violent crime statistics, the number of homicides is a visible, front page indicator of violent crime and drives most of the fear and discussion. To give context to that number, listed on the following page are the number of homicides in Danville for each of the last 63 years. Since 1953 we have averaged 4.88 murders per verified year, but they spike in a recurring pattern due to generational or other intervening factors. During the crack epidemic years of 1988 to 2000, Danville experienced a very high murder rate. During the last 25 years, the lowest rate was three in 2014 and the highest was 16 for this year, 2016. The major shift between a record low in 2014 and a record high in 2016 is indicative of the volatile nature of gun violence in today's world. A major source of firearms for these gun crimes are from burglaries and vehicle larcenies. For example, in 2016, a total of 115 firearms have been stolen in the City of Danville, 46 of them from unlocked vehicles! These firearms are especially prized by teenage male gang members, as evidenced by their willingness to brandish them in pictures on social media.

The world of a teenager is filled with disagreements or perceived disrespect, which results in a shooting, which results in retaliation with another shooting and the number of victims rises until the feud is over. The desire to solve a disagreement by immediately seeking (or always carrying) an easily accessible firearm, which did not happen decades ago, is the overriding reason for the high number of homicides. There is every reason to believe that this year's record spike is transient and will subside, but future spikes are likely and will probably be more frequent.

The problem of seeking a firearm solution to every disagreement has impacted a gang that frequents the Cardinal Place housing complex. Because of continual police disruption of the gang's activity there, the response of the gang has been to target police officers for killing. This new phenomenon first occurred on Friday, October 28, 2016 when an apparent false call was created to lure officers to the area and numerous gunshots were fired at the first arriving officer, with one bullet striking the police vehicle. One week later, on November 4th, another attempt was made on an officer on N. Main St. The Department is taking special response precautions to prevent an officer fatality.







2016 - Other Forcible Sex Offenses





#### **Crime Response Strategies**

The Danville Police Department's response to crime, violent and non-violent, is multifaceted. Listed below are some of the initiatives we are employing to address crime.

- 84% of the Department's officers are involved in street level crime response and investigation. This is greater than the national average of almost 70%.
- A police officer responds to every report of a crime and interacts with the citizen.
- We create a written report for every crime reported to us. Accurate information is necessary to appropriately respond to crime issues and to allocate resources.
- We field a well trained and experienced Investigations
  Unit to investigate major crimes, including homicides.
- We field a well trained and experienced Gang Investigation Unit to monitor and track gang activity.
- While promotions are permanent, assignments are not.
  We rotate personnel through all assignments in the
  Department. The rotation is generally four years, but can
  be longer if necessary. Rotation is critical to: develop a
  flexible and well-rounded workforce; prevent stagnation;
  bring investigative skills back to patrol; plan for
  succession; and find assignments that employees are
  best suited for
- The level of experience of the 18 officers assigned to Investigations is adequate, is appropriately spaced, meets accepted policing standards, accommodates rotations, and, most importantly, works well.



### Crime Response Strategies

- We participate in several task forces that focus on both gang and drug activity.
- We use crime mapping to predict burglaries and assign officers to certain streets and neighborhoods. This has resulted in a significant reduction in burglaries.
- By using location and time data on reported crimes, supervisors are able to direct proactive patrols into geographic areas with higher probabilities of crime occurrence.

### **Crime Response Strategies**

- We participate in the National Integrated Ballistic Information Network (NIBIN) whereby all cartridge cases from crime scenes (including shots fired calls) are collected and their characteristics are entered into a national database to determine linkages.
- We have one officer assigned to our Crime Prevention program who works closely with businesses and citizens managing various programs, including Business Watch, Neighborhood Watch, Crimestoppers, Prescription Drug Take Back, Child Safety, Gun Safety and other citizen education programs.
- Our School Resource Officer Program places officers in the schools to create positive experiences with students and to ensure the safety of the school environment.
- We are actively partnering with the United States
   Attorney in Roanoke to combat violent crime and gang
   activity. We have regular conference calls and his staff
   work closely with Danville Commonwealth's Attorney to
   prosecute, when appropriate, gun cases and other
   violent crimes under the federal system.
- We are actively partnering with the Attorney General's office in Richmond to combat violent crime and gang activity. This office has made thousands of dollars in grants available to us to purchase necessary equipment and engage in community policing initiatives.
- We have hired a grant funded Crime Analyst to provide a higher level of expertise in analyzing our crime and our responses to it.

#### **Crime Response Strategies**

- We are using grant funds to hire a crime expert with the RAND Corporation to perform a link analysis of involvements in our major crimes.
- We are currently applying for a grant to partially fund a legal review and rewrite of the department's entire policy manual and to develop a procedural manual to guide officer interaction with the community. This process will include regular training on policy that will occur throughout the year with the goal of avoiding incidents that contribute to citizen confrontations and civil unrest.
- We have in the last 18 months trained the majority of the officers in the department in Crisis Intervention Techniques (CIT) to enhance the defusing of potentially violent and volatile persons.
- We are partnering with Virginia State University to study our minority hiring practices and develop strategies to improve our success in attracting and hiring minorities.
- We are partnering with Averett University to identify property crime victims and make their homes more secure. The department's Crime Prevention officer performs an analysis of the identified homes and makes security upgrade recommendations. Averett students then help facilitate the security upgrades.
- We suggested, sought funding, and actively participated in the installation of the River District camera system with the goal of expanding it to critical areas in the city.

 We will be seeking funding and support for an alarm reduction program in the 2017/18 budget to reduce the amount of time spent handling false alarms



 We will be seeking funding and support in the 2017/18 budget for a system that tracks and locates gunshots in critical areas of the city so that officers can respond more quickly, gather more evidence and suppress the frequency of gunshots.



 We will be seeking in the 2017/18 budget new, more visible Neighborhood Watch signs for installation in the affected neighborhoods.



- We will be seeking in the 2017/18 budget funding for Civil Disturbance Unit equipment for the entire department so that we can immediately and appropriately respond to disturbances.
- We will be seeking in the 2017/18 budget funding for three additional patrol vehicles to better meet our needs. We will seek additional vehicles in the following fiscal year.

#### Response to Recent Gang Violence

- The Department has worked closely with the Commonwealth's Attorney in the execution of numerous search warrants to disrupt gang activity, learn about the gangs, and arrest gang members.
- We have worked closely with school administration to prevent the gang violence from migrating into the schools.
- We have formed a task force within the department to focus solely on the issue of gang violence.
- We have authorized the expenditure of necessary funds to adequately support these efforts.
- We have modified our tactics in response to gang behavior.
- We are working with other agencies to maximize our intelligence and effectiveness.









### **Drug Arrest Ten Year Trend**









#### Ten Year Warrant Trend

The Danville Police Department handles warrants many ways. Officers obtain warrants for crimes they are assigned to investigate or officers serve warrants obtained by other parties such as private citizens or other law enforcement agencies. The management of these documents falls to the Police Records Division. Once a warrant is obtained, it is entered into the Records Management System (RMS) and is tracked from entry to service. Warrants are also entered into the state and/or national wanted persons data base. Our warrant totals generally average in the thousands and range in subject matter from unpaid parking tickets to murder. The graph below depicts a ten year trend in warrants handled by the Danville Police Department.



#### Police Data Initiative

In April of 2016, representatives from the Danville Police Department met at the White House complex to participate in the Police Data Initiative (PDI), a community of practice that includes leading law enforcement agencies, technologists, and researchers committed to improving the relationship between citizens and police through uses of data that increase transparency, build community trust, and strengthen accountability. This initiative arose out recommendations found in the Task Force on 21st Century Policing. For some time, the Danville Police Department has actively released information on crime to include weekly reported incidents, arrest and warrants. The PDI focuses on police data such as agency employee characteristics, use of force data, community engagement activities and complaints. The Department published our first data set on employee characteristics later in the year and is currently working on publishing the next set on use of force data with others to follow.

#### New Digital Land Mobile Radio System

Following years of research and planning, the City of Danville Public Works Department launched a new digital land mobile radio system. In July of 2016, the Police Department became the first city department to become operational on this new system. It replaced a legacy analog VHF platform that suffered from increasing signal interference, poor signal penetration in large buildings and limitations in range, coverage and functionality.

The new UHF Kenwood Nexedge system, which includes multiple tower sites, mobile (vehicle) and portable (handheld) radios, will eventually serve all departments within the city and provide significantly improved signal range and penetration, clear voice quality in adverse background sound conditions such as wind and traffic. In addition the system will allow for contemporary safety and privacy features such as geo-location and encryption.





#### Police Vehicle Transition From Sedans to SUVs

The modern police vehicle serves not solely transportation, but as a mobile office and communications center for law enforcement officers in the field. Over the number of technology and equipment the components in our vehicles has increased significantly: mobile computer terminals, in-car video systems, eSummons printers and multiple weapon systems just to name a few. Law enforcement agencies across the country have begun to move increasingly toward an SUV platform. Once reserved primarily for rural agencies with challenging terrain or weather conditions, an SUV provides agencies with increased space, size and flexibility to significantly improve officer ergonomics and safety. After a trial deployment of two full-sized SUVs, the Department selected the Chevrolet Tahoe PPV (Police Pursuit Vehicle) as our new police fleet vehicle.

In the fall of the year the Department took delivery of a new Evidence Collection Vehicle for our Crime Scene Unit. The vehicle, based on a Ford E-350 chassis, is purpose-built for this mission. It is a low profile walk-in unit with ample storage for supplies, a generator and air conditioned work space for Crime Scene Techs while staged at a crime scene or other critical event. The vehicle also came equipped new crime scene processing equipment and supplies. It was purchased as a capital and special project to replace a 2004 standard cargo van.


