ANNUAL REPORT 2021

COVID 19 continued to present challenges during the calendar year 2021. Manpower shortages, Deputies working overtime, limits to time off availability, became standard practice. The City of Danville stepped up and approved overtime funds which were used to fill gaps related to the virus. This was particularly relevant with regard to Emergency Custody Orders (ECO's) and Temporary Detention Orders (TDO's). The state issued a \$3,000 bonus to all sworn staff but excluded support staff. Once again, City Manager Ken Larking and City Council rose to the occasion and filled the gap so that all personnel received the bonus. Additionally, all city employees received the same bonus. Sheriff's Office staff members worked with the Health Department and the City's Care Clinic to make the vaccine available for inmates and staff.

Pay Raises - The General Assembly approved a 5% pay raise for all staff members in addition to the aforementioned bonuses. Outgoing Governor, Ralph Northam including funding to increase pay for personnel in his budget. Governor Elect Youngkin promised to make pay for Sheriff's Office staff a priority.

The Sheriff submitted and City Council approved the first ever overtime budget for Deputies. This helped offset the manpower strain some and incentivized personnel to work for pay instead of compensatory time. Note-A major drawback to compensatory time is that it must be managed by taking regular work time taken off which can create further manpower issues.

Recruitment Incentive - At the request of Deputy Astin, the Sheriff implemented a gift card incentive for staff members who recommended job applicants who were hired. Recipients received a \$30 gift card which did not come from city coffers.

Still Perfect! The Sheriff's Office maintained its excellent participation in the United Way fundraiser.

Sheila Hernandez rallied the troops once again for a stellar campaign. An in-house friendly competition revealed that 1st platoon donated the most money for the cause. Shout out to: Sgt. J.J. PRESS RELEASE: CITY JAIL ACHIEVES PERFECT ANNUAL AUDIT RATING DATE: JULY 26, 2021

As Sheriff of the City of Danville, I am pleased to report that the Danville City Jail achieved 100% compliance for the annual Life, Health, Safety standards audit established by the Virginia Board of Corrections.

Understandably, I am very proud of the supervisors and staff in the jail for their efforts to make this achievement possible. Managing Forty-three (43) standards annually for a jail built in the 1970's is a testament to the commitment to excellence by the Deputies and staff who are assigned to the jail. A year ago, our jail achieved a perfect rating for a three-year period with 131 standards. I appreciate and applaud the efforts of all of the men and women who have worked hard to maintain a top-notch facility. While this accomplishment is a team effort, pictured below are the staff members most directly involved with the process.

Intercept Body Scanner-A body scanner was purchased for the jail out of inmate canteen profit account funds. The scanner was a state-of-the-art safety tool to keep inmates and Deputies safe. In practice, every inmate committed into the jail would have their body X-ray scanned for weapons and contraband.





Good News Jail & Prison Ministry begins our 44th year of partnership with the Danville Sheriff's Office as we enter 2022. As with each preceding year, we are blessed by our partnership with these professional staff members and Sheriff Mondul.

Even in the midst of our second year of pandemic concerns, we were able to safely and effectively, conduct numerous programs for inmates within the Danville City Jail including provide a Christmas Gift Bag to each inmate.

During the year, we were able to provide the annual update training for current volunteers to continue meeting stringent state requirements in the area of security, PREA, health issues and suicide awareness. A more comprehensive training is given to new volunteers entering the jail. This training is available to both religious and secular agencies helping to provide hope for a better future to the incarcerated.

Throughout the year, one of our signature programs for inmates continued as often as possible. Several years ago, volunteer Jennifer Williams developed the *2nd Chance Book Club*, encouraging women inmates to read and discuss various books of interest. This important program stresses the need for reading with the knowledge that when we read, we also begin to consider our life and decisions made. It is in such moments, a person may understand the need for change in their lives. While volunteer programs were interrupted at times, I was still able to continue meeting with individual inmates for counseling and Bible study, including emergency notifications as needed.

One of the greatest privileges throughout my 33 years as the chaplain within the Danville Sheriff's Office has been the opportunity of ministry to this professional staff. Whether during a ceremony, a time of sickness or grief, or just at a time of encouragement, it continues to be an honor to be associated with these professionals. Twice each month I was able to provide an email devotional, *The Chaplain's Corner*, for staff members to encourage, as well as, *give a smile to make you think*.



We continue to be proud of the partnership we enjoy with the Danville Sheriff's Office in serving the citizens of Danville. The men and women within the department show a high regard for our community, volunteering with many area agencies including giving of their personal time to help their Good News Chaplain in our public events.
