#### **Annual Report**

Pay Raise overview; Governor Youngkin and the General Assembly enacted 5% pay raises for all Local Constitutional Offices in Virginia. Base pay was raised approximately \$7,000.00 to deal with statewide recruitment challenges. Tenured Deputies with between three and thirty years of service received \$100 per year of service to begin dealing with the compression created by raising base pay.

#### Commendations

Three Danville Sheriff's Office Deputies were recognized for their commendable actions: Pictured (L to R)

-Master Deputy Simmons- Last fall, MD Simmons was operating a Sheriff's Office vehicle with an inmate in custody and avoided being struck by a motorist who ran a red light. The motorist struck another vehicle and flipped two times at the intersection of River Street and the Martin Luther King Jr. Bridge. MD Simmons assisted getting a motorist out of a vehicle and prevented an additional crash by securing the vehicle.

-Corporal A. Taylor was working extra duty at the Crisis Intervention Center. An individual in mental health crisis attempted to assault a clinician but was stopped by Corporal Taylor who used minimal force to diffuse the volatile scenario. Corporal Taylor was hit on the head with an object during the encounter, receiving minor injuries. She was treated and released by medical staff.

-In April of 2021, Deputy J.L. Turner was on security duty at the front door of the Danville Courthouse. A man with mental illness came in and threw a knife at Deputy Turner at close range. Turner's swift reactions and good judgement resulted in no injuries in an otherwise common law enforcement officer shooting scenario. The man was convicted of attempted malicious wounding and sentenced to two years in prison. Sheriff Mondul submitted Deputy Turner for the Virginia Sheriffs' Association Deputy of the Year Award. While he was not selected, he was recognized by the VSA.

All three were recognized with letters of commendation, uniform commendation pins, and a Sheriff Commander's Coin.

Perfect Attendance is achieved by not using sick leave during the calendar year. Bereavement was not counted against perfect attendance. Well done folks, a very dedicated effort once again!

Danville Sheriff's Office and Danville Public Works began working together in September 2022 to allow inmates the privilege to work while incarcerated. Inmates gain on-the-job experience for potential employment. This opportunity is for female inmates who are currently trustee status in the Jail and do not have violent criminal charges or prior history of violent charges. Inmates are monitored by SCRAM Ankle Monitoring System. One inmate has been hired by Public Works as a full-time employee since completing the program in November 2022.






# **VSI Scholarship**



A tour of the jail followed where participants got to experience jail food, the restraint chair, and other procedures in the jail.

# Second Chance Book Club Building Bridges Through Books

A program of Danville Sheriff's Office and Good News Jail and Prison Ministry

Second Chance Book Club was the dream of volunteer Jennifer Williams. She thought of the idea as she drove to her own book club meeting one day in 2018. She began exploring how to make it a reality and worked for nearly a year before launching it in December of 2019.

Because Jennifer only volunteers with women at the city jail she asked them if a book club was an idea they might participate in. Likewise, she knew the funding was on her to find partnerships with local civic groups, churches, individuals and any other source she might discover. My how our community and the book reading world at large has shown up for our inmates!

We began our book reading journey with the classic <u>Tuck Everlasting</u> by Natalie Babbit. This short but timeless book launched many thought provoking conversations and a journey many inmates did not expect to grow to enjoy. **The connection between incarceration and low literacy rates is very strong.** Since Dec. 2019 we have completed 90 novels.

Jennifer tracks (via spreadsheet) how many pages inmates have read and awards certificates to build their sense of accomplishment in a rewarding and helpful activity which can benefit them on the outside.

In January of 2021 she began Second Chance Freedom which allows released inmates to meet at a local deli in the center of town to continue to receive books, catch up with Jennifer and each other, and continue their reading habit.

Men joined the reading ranks in October of 2022 when Sheriff's deputies provided a list of book club books the women had read and they could circle books they might like. Jennifer fulfills these requests from books she has left or women have completed and staff deliver to the men. Success breeds success. Such joy when inmates find great stories to enjoy and discuss.

Together we have observed and been a part of changes made in administration, personnel and especially in the area of security. Throughout every change, the professionalism within the Danville Sheriff's Office has remained a constant in our partnership providing a national example of what can be accomplished as a team.

During 2022 we worked together to provide inmates the benefit from community volunteers conducting religious group studies along with therapeutic and other educational programming in the Danville City Jail.

As the program coordinator, annual update training was provided to current volunteers to continue meeting stringent state requirements in the area of security, PREA, health issues and suicide awareness. A more comprehensive training is given to new volunteers entering the jail. This training is available to both religious and secular agencies helping to provide hope for a better future to the incarcerated.

An exciting program provided by volunteers for the last 7 years has been the "Second Chance Book Club" which encourages reading and discussing books assigned by our coordinator Jennifer Williams. During this time, approximately 1 million pages have been read by inmates.

Along with traditional ministry to inmates, the chaplain also serves as pastor to deputies and staff at the Danville

Sheriff's Office. For the second year, we worked together to host the **Faith & Blue Event**, bringing law enforcement and our many houses of faith together to build "unity in our community."

We continue to be proud of the partnership we enjoy with the Danville Sheriff's Office in serving the citizens of Danville. The men and women within the department show a high regard for our community, volunteering with many area agencies including giving of their personal time to help their Good News Chaplain in our public events.
