# **Re-Entry**

Established a partnership with Norfolk Sheriff's Office to house their female inmates who are eligible for the Recycling Program. Existing partnerships with Martinsville and Pittsylvania County remained lucrative.

To date, three former inmates have been hired by the City of Danville through our Recycling Program.

GED classes are now offered to male inmates (previously only offered to females). One male inmate earned his GED.



Partnerships were established with BrightView, Calm Source, and Crossroads, to provide group sessions (substance abuse counseling) to inmates while incarcerated, along with follow up after care. Inmates completed the registration process while incarcerated.

BrightView awarded the DSO, the Champions of Recovery Award for outstanding service to the recovery community.

Lt. Wyatt presented re-entry presentations for two Rotary clubs and the Danville Host Lions Club to educate our citizens on our efforts to reduce recidivism in our community.















# **Community Engagement**

The Danville Sheriff's Office visited Becky's Kiddie Kollege for Public Safety Week. Students were able to enjoy some time in the cruiser with Sgt. John Phelps and Lt. Jennifer Wyatt.

# Retirement

Inmate jail populations continued to decline across the state. The Danville City Jail's total population fell to a number which allowed for a restructuring initiative, moving female inmates to the main jail. This move significantly consolidated operations, helped with staffing, and saved resources.



Governor/General Assembly Report- Governor Glenn Youngkin and the members of the General Assembly passed budget language which allotted for a 5 % across the board raise in August. There was also compression relief in the form of pay band adjustment and \$100 per service year for sworn staff members who served 3 to 30 years. The G.A. reconvened and passed an additional 2% pay raise in December for all staff.

To address mental health issues in Virginia Jails and better deal with the general health of inmates, the Virginia Compensation Board added two new positions: a Behavioral Health Case Manager and Medical Supervisor. Existing Alpha Coordinator and previous DSO Corporal Crystal Conard was hired for the Behavioral Health Case Manager role and Former DSO LPN Teresa Turner returned to lead the medical unit. Turner was responsible for supervising four Emergency Medical Technician positions. The addition of these two positions necessitated office space for both positions. The jail library was shifted into the chapel and a robust remodel was done, including two modern cubicle office spaces for Conard (L) and Turner (R) along with remodeling office spaces for Lt. Wyatt and Reverend Abernathy.





New Medical, HealthSecure system implemented (June)-The electronic medical record (EMAR did not eliminate paper charts but it decreased the amount of paper put in the charts.)

The new system provided the ability to better document passing of medications and monitor the rate of medication compliance for each individual. HealthSecure monitored the number of medications remaining and automatically refill the medication with our pharmacy vendor when necessary. The system also generates a face sheet with the inmates general information such as: Date of Birth, Social Security Number, booking and ID numbers, confinement date, allergies to medications and foods, medication list, and their diagnosis. When an individual is transferred to another jurisdiction a form is generated that contains most of the above information in addition to where they are going, when a TB test was given, and date it was read. If that person required a chest x-ray or a tetanus injection that is also noted on the transfer form. HealthSecure allows alerts to be placed on the chart to note medical and mental health risks associated with the individual which makes things safer for the inmate and the staff alike.

There is also a shared calendar that notes all outside appointments or when an individual is scheduled to have an injection.


### **Commendations**

Renovations at the Municipal Building (City Hall) continued. The Commonwealth Attorney relocated to the main floor formerly occupied by the Danville Police Department. Civil Process Sergeant and Training Coordinator, Sgt. Thomas Rigney relocated from the Civil Process Office in the Courthouse to an office located in City Hall adjacent to the existing security office. Plans were made for office space in the old IT server area of City Hall for Major Martin and the recruitment officer to have office space.

The space next to the Sheriff's Office in the front of the courthouse was renovated and transformed into a meeting room for the Grand Jury, Jury Orientation, and could also be used for scheduled meetings. The room was built to about 60 people.

New plaques were placed in the jail break room and in the civil process office to recognize firearms accuracy for deputies individually and as a platoon/team.

New Project Lifesaver Vehicle-In May, the Womack Foundation Donated \$40,000 to the Sheriff's Office to purchase a new vehicle for PLS. The existing PLS vehicle was added to the fleet. PLS had thirty-two active clients within the City of Danville by the end of the calendar year. "Project Lifesaver is the premier search and rescue program operated internationally by public safety agencies, and is strategically designed for "at risk" individuals who are prone to the life threatening behavior of wandering. The primary mission of Project Lifesaver is to provide timely response to save lives and reduce potential injury for adults and children with the propensity to wander due to a cognitive condition." PLS is cost free to citizens of Danville because of donors and fundraisers.



# FAITH & BLUE BRIBGING 2023











The Third annual "Faith and Blue" event was hosted by the Danville Sheriff's Office, Danville Police Department, and Good News Jail & Prison Ministry.

The Faith in Blue event is a continued national partnership between law enforcement agencies and the local faith-based community.

The 2023 Faith and Blue event was held at the Dan River Church parking lot on October 7<sup>th</sup>.



No Shave November & December is an annual initiative to help make Christmas a little brighter for local children. After the Sheriff relaxed the grooming policy, deputies donated \$25.00 both months to grow beards, wear different nail polish and/or different earrings than what is normally permitted within policy. A total of \$1,200.00 was raised and used to purchase toys. The DSO partnered with the Danville Police Department's "Santa's Little BLUE Helpers" to give out the toys. Deputies worked with Police Officers and Santa Claus to provide a positive Christmas experience for needy children while improving their outlook of uniformed law enforcement officers.


















The new Crisis Center featured partnerships with the Danville Police Department, the Pittsylvania County Sheriff's Office, Danville Pittsylvania Community Services Board, and the Danville Sheriff's Office. The Memorandum of Understanding dictated that all four partners would have a stake in the Crisis Center, with all three law enforcement agencies having at least one full-time employee assigned to the center. At the end of the calendar year, the DSO had two employees hired of the four. The other two agencies were completing the hiring process to fill the slots.

#### The Crisis Center:

Since July 2021- State expectations of Emergency Services and a Mobile Crisis Program changed, which meant Danville-Pittsylvania Community Services Board (DPCSB) programs needed to be reevaluated. The Emergency Services and the Mobile Crisis Program Merged to became "CRISIS SERVICES," which meant there would be 24/7 Community based and Office based access to services in two locations, DPCS- East Wing 8:30-3:30 Monday- Friday and the Crisis Center- 136 West Main St. 24 hours per day, 7 days a week.

The Crisis Center, now located at 366 Piney Forest Rd., provides a safe, less restrictive, and comfortable environment for persons experiencing distress and impairment due to the impact of situational or psychiatric crises. The crisis center is open 24 hours per day, 7 days per week and houses staff that provides Emergency Services, Mobile Crisis, and Community Crisis Stabilization services. Currently we have 4 teams to cover a 24/7 community response program. Each team has 3-4 staff comprised of Licensed Clinicians to facilitate prescreen assessments, Care Coordinators who link individuals to services and advocate for individual's rights, and Peer Recovery Specialists who serve as role models and mentors for the individuals. In addition, the Crisis Intervention Team Assessment Center (CITAC) is located within the Crisis Center and staffed by a CITAC Officer. CITAC Officers are vital in hospital diversion care by assisting the Crisis team to provide services to our individuals, as well as providing a safe environment for the individuals and staff. The goal is to have 24/7 coverage with full-time CITAC Officers.

#### Daily Goals of the Program:

- · De-escalate behavioral health crises
- · Establish safety and link them to ongoing services
- Help empower people to be the hero in their own lives
- · Avert from Jails and/or hospitalizations
- Serve the individuals in the community

#### **Preadmission Screening**

Evaluations for Inpatient treatment and psychiatric bed placement

#### CITAC

• Safely provides a therapeutic environment for individuals who come into contact with law enforcement and are in the midst of a mental health crisis and/or experiencing substance abuse issues.

#### **Mobile Crisis**

Immediate crisis intervention services dispatched to anywhere in Danville City/ Pittsylvania County

#### **Community Crisis Stabilization**

• Transitional services to help assist in managing crisis level symptoms while setting the person up for ongoing services/ treatments.

#### 23 Hour Observation

 Assessment and stabilization interventions to individuals experiencing a behavioral health crisis for a period of up to 23 hours in a community-based clinic setting

## **Second Chance Book Club**

#### **Building Bridges Through Books**

A program of Danville Sheriff's Dept. and Good News Jail and Prison Ministry

Second Chance Book Club was the aspiration of volunteer Jennifer Williams. She thought of the idea as she drove to her own book club meeting in 2018. She began exploring how to make it a reality and worked for nearly a year before launching it in December of 2019.

Because Jennifer volunteers with women only at the city jail, she asked them if a book club was an idea, they might participate in. Likewise, she knew the funding was not budgeted. She sought to find partnerships with local civic groups, churches, individuals, and any other source she might discover. My how our community and the book reading world at large has shown up for our inmates!

We began our book reading journey with the classic <u>Tuck Everlasting</u> by Natalie Babbit. This short but timeless book launched many thought-provoking conversations and a journey many inmates did not expect to enjoy as they did. **The connection between incarceration and low literacy rates is very strong.** Since Dec. 2019 we have completed 148 novels.

Jennifer tracks (via spreadsheet) how many pages inmates have read and awards certificates to build their sense of accomplishment in a rewarding and helpful activity which can benefit them on the outside.

In January of 2021 she began Second Chance Freedom which allows released inmates to meet at a local deli in the center of town to continue to receive books, catch up with Jennifer and each other, and continue their reading habit.

Men joined the reading ranks in October of 2022 when Sheriff's deputies provided a list of book club books the women had read, and they could circle books they might like. Jennifer fulfills these requests from books she has left, or women have completed, and staff deliver to the men. Success breeds success. Such joy when inmates find great stories to enjoy and discuss.

This year we added 2 Retro Reads which provided 32 classic Children's novels such as Charolette's Web, Boxcar Children, Babysitter's Club and Ramona the Pest. We loved discussing the memories they brought back.

We are proud to be celebrating 46 years of partnership between the Danville Sheriff's Office and Good News Global, formerly, Good News Jail & Prison Ministry, in 2024. Together we have observed and been a part of many changers through the years. Whether the change has been in the area of security, or in our case, a new name and updated logo, the professionalism within the Danville Sheriff's Office has remained a constant in our partnership providing a national example of what can be accomplished when working as a team.

During 2023 we worked together to provide inmates the benefit from community volunteers conducting religious group studies along with therapeutic and other educational programming in the Danville City Jail.
