Citizen Police Academy

The Danville Police Department is currently offering the Citizen Police Academy to the residents of the City of Danville, VA. Participation in the Citizen Police Academy is free of charge to those who are accepted.

The academy is designed to give individuals the opportunity to learn more about the operations of their police department, police procedures, and to foster enhanced understanding and cooperation between the police and the community they serve. It is **NOT** intended to make citizens into police officers but rather heighten awareness of both the public and the police in an effort to develop a partnership between both. The Danville Police Department's primary objective is to provide an interactive instruction in many basic police department tasks as well as provide an opportunity to have a hands-on experience with the tools of the police trade.

The Citizen Police Academy requires a	commitment of one night per week for eight (8) weeks. The
sessions will begin on Tuesdays	, from 6:00pm-8:30pm and will continue every Tuesday
evening through Tuesday,	The Academy will cover topics such as Laws of Arrest,
Penal Code, Patrol Procedures, Crime S	Scene Investigation, and Use of Force.

Qualifications for application:

- -Applicants must be at least 18 years old.
- -Applicants must be a Danville city resident, work/own a business in the City of Danville, or attend school in the City of Danville.
- -Applicants can NOT have any Felony Convictions *Misdemeanors will be handled on a case-by-case basis.*
- -Applicants must be able to provide their own transportation to and from the Academy.
