PIEDMONT AUTHORITY FOR REGIONAL TRANSPORTATION

The Piedmont Authority for Regional Transportation (PART) serves Greensboro, Winston Salem, High Point, Alamance Burlington, Thomasville, Ashboro Randelman, Chapel Hill and Kernersville, North Carolina. In addition, PART also provides on-demand shuttle service to the Piedmont Triad International Airport.

PART's One-way Fare is \$2.50. Half-fares are offered for seniors, students and veterans. Passenger can pay the bus fare using cash, the Umo Mobile App, Umo Online Portal or Smartcard.

The Triad-Danville Connector bus route serves the Reidsville Walmart where passengers can access skat bus routes.





RESERVE A RIDE INFORMATION

Days of Service: Monday through Saturday

Door to Door One-Way Bus Fare: \$4 base fare. Two (2) children up to 12 years old and younger can ride for free with a paying adult.

Student Fare: \$2 fare requires appropriate identification and student discount card. To receive the discount card, students should complete an application at the Transfer Center, 515 Spring Street, Danville, Virginia 24541.

Service Area: Trips provided to **any** location within the City of Danville and Cane Creek Centre Industrial Park. On Saturdays **only**, from noon until 12:45 am, service is provided within 10 miles of the city limits of Danville.

Service Hours: 4:00 am - 1:00 am, the last boarding time is 12:45 am. Danville Transit encourages passengers to sign up for **text alerts** that will provide updates concerning possible service schedule changes. **To receive text alerts, please text 24541 to dtupdate.**

Boarding Time Window: Passengers will be notified the night before when service will be provided by an automated phone system. The message will identify the boarding time, which includes a thirty (30) minute window. For example, if a passenger is notified that your boarding time is between 7:00 am and 7:30 am, then the passenger should be ready to board at 7:00 am.

Text Message sent regarding boarding time: Passengers will receive a text message informing them a few minutes in advance when the bus will arrive.

Reservation and Cancellation Options: Please call 799-5144, Option #2 to reserve or cancel service. Passengers can also cancel service by visiting the transit system's webpage by clicking **Cancel Bus Trip** and filling out a form to **cancel** a scheduled trip.

Prior day trip requests that are called in must be received by 3:00 pm the day before service is desired to be scheduled for the following day. Service can be reserved for one or more days unless a cap on reservation exists.

Reservations must be submitted within 7 days of the trip request.

Scheduled boarding times: Boarding times may vary daily based on passenger reservations received. An automated phone system will notify passengers of your scheduled boarding time by 5:00 pm. Please call (434) 799-5144 if you do not receive this notice.

Same-Day Trip Requests: Passengers call (434) 799-5144 to submit a same-day trip request between 4:00 am and 11:00 pm. **Same-day rides are not guaranteed due to possible capacity limitations.**

RESERVE A RIDE POLICY AND PROCEDURES

Reservation Limitations - The number of reservations that are processed daily may be restricted due to limited resources. As a result, passengers could be informed that their reservation cannot be scheduled. If so, please call back the transit office to see if a cancellation occurred that would allow for your trip to be scheduled.

Cancellation Policy - Passengers must call 60 minutes in advance of their scheduled trip time to cancel service. However, a pattern of cancellations may result in suspension of service for one week. This policy is necessary to promote fair and efficient Reserve A Ride operations. Prior day cancellations do not apply to this policy.

No Show Policy - If a scheduled trip has not been cancelled within one hour and the bus arrives at the pick up location and the passenger is not present to board then the passenger will be charged for that ride. If a passenger maintains three (3) no shows then payment for each no show must be provided in advance to staff at the Transfer Center, which is located at 515 Spring Street or to the driver to receive service.

SENIOR TRANSPORTATION, TITLE VI RIGHTS AND END OF LINE INFORMATION

Half Fare Discount Period & Transportation Options for Seniors

The fixed-route half fare discount period for persons 60 years old or older, Medicare Card Holders and persons with disabilities is from 6:00 am until noon, Monday through Saturday. Also, persons 60 years old or older can make a reservation to receive door to door service that involves a requested voluntary donation. This service is provided through coordination efforts with Danville Transit and the Southern Area Agency on Aging. For more information about this program, please call Danville Transit at (434) 799-5144.

If a transfer is required and the location is not along the path to the garage then passengers may use the Reserve A Ride service to reach their destination.
