ONE TON, FIFTEEN (15) PASSENGER VAN, GASOLINE ENGINE

Model: 2025 or current year model, New, One Ton, Fifteen (15) Passenger Van.

GCWR: 16,000 lbs. min

Wheelbase: 155" minimum.

Engine: V-8 Gasoline Engine with gaseous prep package.

Axle/Springs/Frame: As required for vehicle GCWR.

Transmission: Automatic w/overdrive, auxiliary oil transmission cooler as available from the manufacturer or dealer.

Steering: Power steering, adjustable tilt-wheel.

Brake System: Power disc brakes on all wheels with Anti-lock Braking System (ABS).

Restraint system: Front driver and front passenger air bags required.

Bumpers: Front bumper, rear step bumper.

Fuel System: Manufacturer's standard single fuel tank.

Tires: Manufacturer's standard tire. All primary tires and wheels shall be identical (i.e., no cross brands or models). Each vehicle shall be equipped with a full-size spare tire. Spare tire may be mounted on a traditional steel wheel. All tires and wheels shall be properly balanced.

Mirrors: Folding, Extendable Trailer Tow Mirrors w/ integrated spot mirrors, heated, power adjustable,

Interior: AM/FM/CD Stereo radio, power door locks, power windows, cruise control, cloth seats, driver & front passenger floor mats, vinyl flooring, 3 sets keys & key fobs (all keys must start vehicle at time of delivery), daytime running lights (DRL), dual note horn, sliding right hand door.

Air Conditioning: Manufacturer's heavy duty front and rear air conditioner.

Windshield Wipers: Electric, two speed, with intermittent wipe and washer system.

Glass: All glass shall be standard factory tinted and fixed.

Rear Window: Fixed with defogger, rear vision camera.

Instrumentation: Factory installed gauges and dome light.

Towing: Heavy duty tow package including Class III receiver, HD Flasher and 7-wire pin type connector (RV type will not be accepted), Heavy duty locking rear differential, electric brake control (Factory Installed), Backup alarm (97 decibels minimum)

License plate bracket: Vehicle to be equipped with front and rear license plate bracket.

Running Boards: Factory mounted left (driver only) and right (full length) running boards (nurf bars or hoop steps will not be accepted) rear molded splash guards
