#### **Major Revenue Sources**

The major revenue sources for this fund include:

**LICENSES, PERMITS, PRIVELEGE**: This revenue includes Cemetery permit fees for monuments and vaults.

**REVENUE – USE OF MONEY/PROPERTY**: This revenue includes interest on investments; sale of grave lots; and perpetual care not previously paid.

**CHARGES FOR SERVICES**: This revenue provides for opening/closing of grave fees.

**NON-REVENUE RECEIPTS**: This revenue is an offset of the Cost Allocation expense. The allocation provides a method of showing the administrative costs covered by the General Fund. The Cemetery Fund is an enterprise fund and as such these administrative costs need to be included to reflect the complete cost of Cemetery operations.

**TRANSFERS IN**: The Cemetery Fund is designed to provide revenues to cover all the costs of operation; however, when the Fund Balance is insufficient to cover cost overruns, a transfer from the General Fund is required.

Additionally, this fund also aids with genealogy requests.

The eight (8) city-owned cemeteries are Freedman's, Green Hill, Grove Street, Highland Burial Park, Leemont, Mountain View, Oak Hill, and Schoolfield.
